In 2021, with the continuation of the pandemic, we continued to support Ottawa women professionals and entrepreneurs in a virtual format, with online events. We were very pleased to close out our year with an in-person Holiday Social highlighting Nita Tandon, founder of award-winning DALCINITM Stainless houseware, a line of durable, chemical-free stainless steel food containers. During the pandemic we also promoted the products and services of local businesses KIN Vineyards, Equator Coffee of Almonte, Stubbe Chocolates, Strawberry Blonde gluten-free bakery, as well as fashion and fabric specialists Capsule Creations and Bank & Vogue.

Our sister OWIT chapters around the world were also active, here are some examples:

- OWIT Toronto held a fascinating event in November on The Global Supply Chain Grinch that could Steal Christmas
- OWIT Nairobi participated in the African Women in Trade Conference, together with OWIT Nigeria and Zimbabwe
- Tampa Bay was able to hold its annual awards ceremony, as well as a winter winetasting event
- Washington DC held an event on music and digital trade in the Middle East, and their annual Gala, which included a how-to on making signature cocktails

OWIT now has two new chapters, OWIT UK and OWIT Brussels. OWIT Ottawa is looking forward to co-hosting events with them and supporting them as they get established. As a reminder, membership in OWIT Ottawa provides membership in the OWIT International network, and to participate in events organized by OWIT chapters world-wide.

Partnerships and policy directions

Our partnerships outside the OWIT family have strengthened in several directions. Last year we were invited by the Trade Commissioner Service of Global Affairs Canada to join the CUSMA SME Counsellor Network Pilot Program to exchange information and best practices, develop partnerships and engage in joint activities, several of which are in the planning stages.

During the pandemic, the Women Entrepreneurship Knowledge Hub (WEKH), produced two annual reports (2020, 2021) surveys the latest research on women entrepreneurs in Canada, —with particular emphasis on the impact of the COVID-19 pandemic on diverse women entrepreneurs, the inclusive innovation ecosystem, and emerging initiatives to support women entrepreneurs.

Our chapter has been privileged to participate in the global conversation on the status of women entrepreneurs and steps to take to overcome challenges they face.

In early January, Tamaîka and I were honoured to participate in the Ottawa conversation of the prestigious Reykjavik Global Forum hosted by the Ambassador of Iceland. We discussed women's issues touching on equality, sustainability and creating humanitarian initiatives to advance the cause of women.

We also participated in the January launch of the report Gender Mainstreaming in Free Trade Agreements: A Regional Analysis and Good Practice Examples, by Dr. Amrita Bahri, funded by the UK Foreign, Commonwealth and Development Office (FCDO) and implemented by Cowater International, and OWIT Ottawa sponsor. The study examines gender-specific challenges in international trade and puts forward a series of recommendations for policymakers and trade professionals on how to advance gender-related issues in free trade agreements. Expert panelists from the WTO, UNCTAD and academics discussed the study's findings with Dr Bahri, moderated by Don Stephenson, former Canadian Ambassador to the WTO.

During March celebrations for International Women's Day, we will be holding a Mix and Mingle event, inviting women and men both new to international trade and enjoying established careers in this field, to share their experiences in small groups over a glass of wine, and to give people a taste of our upcoming mentorship program. Stay tuned over the next few weeks, as we determine whether the event will be in person or online.

One of our focusses this year will be examining how to plan for a post-pandemic world, as effects on trade and business continue, often in sudden and unexpected ways. We will be convening experts and partners who will delve into some of these questions and propose some innovative solutions. Events to be announced soon.

Among other things, she is committed to continue to advance Canada's global leadership on critical minerals by working with international partners and allies, including through the implementation of the Canada–U.S. Joint Action Plan on Critical Minerals Collaboration and the Canada-EU Strategic Partnership on Raw Materials.
